MEMORANDUM FOR SMC DIRECTORS

SUBJECT: Redlegation of Specific Contracting Authorities

Consistent with the AFFARS [2002 Edition] and pursuant to my authority as Program Executive Officer (PEO) and Head of Contracting Activity (HCA) for Space PEO Programs, I redelegate the following specific contracting authorities unless retained by USECAF or PEO/SP. As HCA, I authorize SMC/PK to establish clearance procedures as required by AFFARS 5301.9001(b).

(1) Acquisition Plan (AP) Approval:

To the System Program Director (SPD) for actions <\$50M.

(2) Acquisition Strategy Panel (ASP) Chairperson

To the SPD for actions <\$50M

(3) Source Selection Authority (SSA):

To the SPD for actions \geq \$10M to <\$50M

(4) Undefined Contractual Action (UCA) Approval:

To the SPD for actions <\$50M

(5) Solicitation Review (RFP), Clearance Reviewing Authority (CRA), and Clearance Approving Authority (CAA):

RFP/CRA and CAA to the CO for all actions <\$10M

RFP/CRA to the BOCO for all actions \geq \$10M to <\$50M

RFP/CRA to the SCCO for all actions \geq \$50M

CAA to the SSA for Competitive actions \geq \$10M

CAA to the SPD for Non-competitive actions \geq \$10M to <\$50M

(6) Fee Determining Official (FDO):

To the SPD for contracts valued <\$50M w/o power of redelegation

(7) Approve Justifications (J&As):

To SMC/PK for actions >\$500K to ≤\$50M

(8) Ratify unauthorized commitments:

To SMC/PK for all \$ amounts so long as PK is at least one level above the party who committed the action


(9) Approve individual (one-time) deviations to the FAR and its supplements except as restricted by DFARS Subpart 201.4:

To SMC/PK

Pursuant to authority delegated to me under AFSPC FARS 5301.601(a)(ii), I redelegate the following contracting authorities to SMC/PK for Other Contracting actions except 61st CONS:

- (1) Make awards and grant clearance approvals without limitation as to dollar amount.
- (2) Approve individual deviations to the FAR and its supplements.
- (3) Ratify unauthorized commitments for all \$ amounts so long as PK is at least one level above the party who committed the action.
- (4) Appoint contracting officers.
- (5) Approve the use of UCAs.

These redelegations do not affect my authority to exercise (retain) any of the authorities redelegated or to issue instructions concerning the exercise of those authorities. The System Program Director may redelegate specific contracting authorities.
